**RECOMMENDATION:** The City Manager recommends approval of Temp. Reso. No. 8511 for the renewal of software licenses and maintenance services with Ultimate Kronos Group ("UKG") in an amount not to exceed \$90,339 for Fiscal Year 2026; and for the renewal of security software licenses and maintenance services from Alchemy Technology Group in an amount not to exceed \$120,676 for Fiscal Year 2026.

**ISSUE:** City Commission approval is required for expenditures exceeding \$75,000 in accordance with City Code Section 2-412(a)(1).

**BACKGROUND:** In November 2021, the city entered into a three-year agreement with UKG Dimensions for a cloud-based timekeeping software system, with a 12-month renewal period, utilizing Omnia Partners contract number 18220 and resolution 22-26.

The City uses security software for monitoring, protecting, and managing sensitive data on the City's network. This security software enables the City to effectively detect and respond to insider threats, data breaches, and other cybersecurity risks.

<u>DISCUSSION:</u> The renewal of software licenses and maintenance services for a oneyear period is essential to ensure continued use and maintenance of the City's current timekeeping system, as well as to support ongoing efforts to monitor and protect the City's data from cybersecurity threats.

Pursuant to City Code Section 2-413(11)c, renewal of software license and maintenance services are exempt from competitive bidding.

**ANALYSIS:** Funding of \$211,015 is available in the Information Technology Fund, GL Account 504-58-580-516-000-603425, Software License and Maintenance.


