FIRST READING of Temp. Ord. No. 1849 Budget Amendment for FY25

RECOMMENDATION: The City Manager recommends approval of Temp. Ord. No. 1849, providing for the second budget amendment of the Fiscal Year 2025 Operating and Capital Improvement Program Budgets.

ISSUE: Pursuant to Section 2-203(a), City Commission approval is required to amend the budget by passage of an ordinance.

BACKGROUND: Per F.S. 166.241(5), the governing body can amend the Fiscal Year 2025 Operating and Capital Improvement Program Budgets only via ordinance.

DISCUSSION:

Fire & EMS CIP Fund (381):

Fire Station #19 (CIP Project #53020) This project is partially funded by the FEMA Hazard Mitigation Grant Program (HMGP) at 75% with a 25% City's matching contribution. The scope of work for this project includes the replacement of the bay door with a wind-resistant door, and the installation of a manual transfer switch. Due to a cost increase, the initial funding allocation was quickly depleted by the purchase and installation of the bay door. City's staff requested additional support from FEMA to complete the project. FEMA granted additional funding with a 25% match requirement. We are requesting additional funding allocation from fund balance in the amount of \$9,381.92.

- Fire Station #84 (CIP Project #53022) This project is partially funded by the FEMA Hazard Mitigation Grant Program (HMGP) at 75% with a 25% City's matching contribution. The scope of work for this project includes the replacement of the bay door with wind-resistant door, installation of a new permanent generator, and the installation of a manual transfer switch. Due to a cost increase, the initial funding allocation was quickly depleted by the purchase and installation of the bay door. City's staff requested additional support from FEMA to complete the project. FEMA granted additional funding with a 25% match requirement. We are requesting additional funding allocation from fund balance in the amount of \$20,262.92.
- Fire Station #100 (CIP Project #53023) This project is partially funded by the FEMA Hazard Mitigation Grant Program (HMGP) at 75% with a 25% City's matching contribution. The scope of work for this project includes the replacement of the bay door with a wind-resistant door, and the installation of a manual transfer switch. Due to a cost increase, the initial funding allocation was quickly depleted by the purchase and installation of the bay door. City's staff requested additional support from FEMA to complete the project. FEMA granted additional funding with a 25% match requirement. We are requesting additional funding allocation from fund balance in the amount of \$13,908.99.

<u>ANALYSIS:</u> The following items are included in the first Fiscal Year 2025 budget amendment:

Fire & EMS CIP Fund (381) – Exhibit A

Revenues (\$43,553.07 adjustment)

 Appropriation of Fund Balance: Increase \$43,553.07 from the Fire & EMS Fund Balance to appropriate funding for the completion of the three Fire Station's Project (CIP Project #53020, #53022 & #53023) as shown below.

Expenses (\$43.553.07 adjustment)

- Fire Station #19 Project (CIP Project #53020): Increase the construction account by \$9,381.92.
- Fire Station #84 Project (CIP Project #53022): Increase the construction account by \$20,262.16
- Fire Station #100 Project (CIP Project #53023): Increase the construction account by \$13,908.99

WHEREAS, based upon the periodic review and analysis of current budgetary commitments and obligations, the projected needs and requirements of the City and the recommendations of the City Manager, and with the concurrence of the Finance Director as to Accounting Principles, it is deemed necessary to adjust, amend, and implement the Fiscal Year 2025 Operating and Capital Improvement Program Budget; and

WHEREAS, the proposed amendment to the Fiscal Year 2025 Operating and Capital Improvement Program Budget is set forth in Exhibit "A," attached hereto and made a part hereof; and

WHEREAS, Section 2-203(a) of the City Code provides that "if during the fiscal year, revenues in excess of those estimated in the budget are available for appropriation, the City Commission may make supplemental appropriations for the year up to the amount of such excess:" and

WHEREAS, this Ordinance will provide funds for additional new projects and unanticipated expenses, as well as for projects that have been previously approved; and

WHEREAS, the City Manager and the Management & Budget Director recommend approval of this Ordinance, providing funds for additional new projects and unanticipated expenses, as well as for projects that have been previously approved; and

WHEREAS, the City Commission deems it to be in the best interest of the citizens and residents of the City of Miramar to amend to approve the second amendment of the Fiscal Year 2025 operating and capital improvement budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA AS FOLLOWS:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are made a specific part of this Ordinance.

Section 2: That it approves the amendment of the Fiscal Year 2025 Operating and Capital Improvement Program Budget as set forth in Exhibit "A," attached hereto and made a part hereof.

Section 3: If any clause, section, or other part or application of this Ordinance shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and shall not affect the validity of the remaining portions or applications, which shall remain in full force and effect.
