of Yuris Sanchez vs. City of Miramar

RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No 8512, authorizing settlement of the automobile bodily injury claim involving Yuris Sanchez v. City of Miramar, Claim #010586-006130-AB-01, for the sum of \$50,000. Settlement was negotiated by Gallagher Bassett, the City's Third-Party Administrator for liability claims.

ISSUE: Mr. Yuris Sanchez was driving west on 151 Southwest 184th Avenue, Pembroke Pines. City employee Rohan Byfield was travelling in the same direction behind Mr. Sanchez in the course and scope of his employment. Mr. Sanchez made a complete stop at a posted stop sign, however Mr. Byfield continued forward and rear-ended Mr. Sanchez's vehicle. The recommendation to settle will resolve this claim in its entirety. Since the \$50,000 negotiated settlement exceeds the City attorney and Gallagher Basset's authority level, the City Commission's approval is required.

BACKGROUND: On January 17, 2025, Mr. Yuris Sanchez allegedly suffered personal injuries when a vehicle driven City employee Rohan Byfield rear-ended the vehicle he was driving. The accident occurred in the vicinity of 151 SW 184th Avenue, Pembroke Pines. Although no citation was issued, the police report placed fault on the City driver's actions, for operating the vehicle in a careless manner. Mr. Sanchez retained the services of Kelly Dominguez Esq., of The Founders Law, who proffered a demand for \$200,000 to resolve her client's claim.

<u>DISCUSSION:</u> Mr. Sanchez sought treatment for his injuries and provided substantiating medical specials totaling \$46,054.47, primarily for lumbar injury, with future medicals anticipated at \$727,700.

ANALYSIS: Liability is undisputed, so negotiations primarily focused on amicably resolving damages, which Gallagher Bassett was able to accomplish on the City's behalf for \$50,000, in exchange for a full release.

WHEREAS, the parties have agreed to settle all issues involved in the Claim for personal injury for the total sum of Fifty Thousand Dollars (\$50,000.00); and

WHEREAS, neither party admits liability in this matter, however, in an effort to resolve the pending controversy, all parties desire to amicably and expeditiously resolve all claims and avoid continued litigation; and

WHEREAS, the City Commission hereby accepts the recommendation of the City's Risk Management Department to settle this matter consistent with the Claim Reso. No. _____

WHEREAS, the parties desire to enter into a Claim Release Agreement with the intended purpose of resolving all claims set forth in Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA AS FOLLOWS:

This Indenture Witnesseth that I, YURIS SANCHEZ consideration of the sum of FIFTY THOUSAND DOLLARS and 00/100 (\$50,000.00), do hereby for my heirs, personal representatives and assigns, release and forever discharge Gallagher Bassett Services, Inc., ROHAN BYFIELD, CITY OF MIRAMAR, and any other person, firm or corporation charged or chargeable with responsibility or liability, their heirs, representatives or assigns, from any and all claims, demands, damages, costs, expenses, loss of services, actions and causes of action arising from any act or occurrence up to the present time, and particularly on account of all personal injury, disability, property damages, loss or damages of any kind sustained or that I may hereafter sustain in consequence of an accident that occurred on or about the 17th day of January 2025, at or near 151 S.W. 184th Ave., Pembroke Pines Florida

To procure payment of the said sum, I hereby declare: that I am more than 18 years of age; that no representation about the nature and extent of said injuries, disabilities or damages made by any physician, attorney or agent of any party hereby released, nor any representations regarding the nature and extent of legal liability or financial responsibility of any of the parties released, have induced me to make this settlement; that in determining said sum there has been taken into consideration not only the ascertained injuries, disabilities and damages, but also the possibility that the injuries sustained may be permanent and progressive and recovery there from uncertain and indefinite, so that consequences not now anticipated may result from the said accident.

The Undersigned Agree(s), as a further consideration and inducement for this compromise settlement, that it shall apply to all unknown and unanticipated injuries and damages resulting from said accident, casualty or event, as well as to those now disclosed.

I understand that the parties hereby released admit no liability of any sort by reason of said accident and that said payment and settlement in compromise is made to terminate further controversy respecting all claims for damages that I have heretofore asserted or that I or my personal representatives might hereafter assert because of said accident.
