**RECOMMENDATION:** The City Manager recommends approval of Temp. Reso No. 8485, approving Amendment No. 2 for additional design and consulting services for the New Community Youth Center, CIP Project No. 53027 ("Project"), to Walters Zackria Associates, PLLC., ("Architect"), authorizing the City Manager to execute the proposed amendment with the Architect for the provision of additional design services for a total cost of \$214,430.

**ISSUE**: Amendment No. 2 needs approval from City Commission to procure additional design and consulting services from the Architect involved in this project. Per City Code, Section 2-412 (a)(1), Commission approval is required for expenditures by a single department for the same vendor exceeding \$75,000.

**BACKGROUND**: On September 27, 2021, the City Commission accepted and adopted the City's Capital Improvement Program plan for FY 2022-2026 with Resolution Number 21-163. The replacement of Vicki Coceano Childcare Facility with the New Community Youth Center, CIP Project No. 53027, was part of the adoption.

November 14, 2022, City Commission adopted Resolution Number 23-26, authorized the City Manager to award Request For Qualifications Number 22-01-15 and executed the agreement with Walters Zackria Associates, PLLC, to provide design and consulting services for the New Community Youth Center for \$454,585.

On January 24, 2024, the City Commission adopted Resolution Number 24-56 approving the Award of Amendment No.1 for additional design services in the amount of \$316,000 to Walters Zackria Associates, PLLC, to increase the facility size of the New Community Youth Center.

In 2024, the City received a federal legislative appropriation of \$1,000,000 from the Department of Housing and Urban Development to supplement the construction costs of the New Community Center sponsored by Congresswomen Frederica Wilson.

In 2025, the City received an additional federal legislative appropriation of \$1,000,000 from the Department of Housing and Urban Development to further supplement the design of the New Community Youth Center and include additional outdoor recreational activities geared towards youths.

As a result, additional design and consulting services are needed for which the A&E of record, Walters Zackria Associates, PLLC, submitted Amendment No. 2 in the amount of \$214,430.

<u>DISCUSSION</u>: Amendment No. 2 allows Walters Zackria Associates, PLLC, to modify the original scope to include the design of outdoor recreational activities to enhance the New Community Youth Center design.

Approval is needed of Amendment No. 2, in the amount of \$214,430. The total cost for the design services for the project, including this Amendment No. 2, is \$985,915.

<u>ANALYSIS</u>: Funding in the amount of \$214,430 is available in the City's Capital Improvement Program (CIP) Project No. 53027 – New Multi-Purpose Recreational Facility GL Account No. 395-55-800-575-000-606510-53027 CIP-Construction.
