The Miramar Sister Cities Board was created [Ordinance number 22 -1, 10/13/21] to analyze issues affecting sister city relationships and make recommendations to formalize these relationships – becoming an official Sister City with the City of Miramar. The purpose of this report is to highlight the board's activities in the most recent quarters (Q1 - Q2 2024) and those that are planned soon.

## 2. Board Composition

There are seven city commission-appointed members on the board: one appointed by each commissioner; one who owns, manages, or operates a business; and one who represents an educational institution. Below is information on the current board members:

# 3. Meetings and Activities

At the meetings in Q1 - Q2 2024, the Board has discussed the following:

- Explored different activities to pursue with the new sister city
- Reviewed past activity to investigate Potential Sister City Relationships
- Followed up with local Belizean organizations
- A delegation representing Belize City, consisting of its mayor and two Councilors visited Miramar. Over a 3-day period, the Board's first Sister City Agreement was signed. The delegation met several times with the Board and the Miramar Commission, was given tours of the City, met with different City department leaders, and participated in the Signing Ceremony.

## 4. Accomplishments and Outcomes

The major accomplishments were the signing of the Sister City Agreement with Belize City; and the discussion of future mutually beneficial projects along with a reciprocal visit to Belize City by a Miramar delegation to include the Commission, Staff, and local businesses.
