**RECOMMENDATION:** The City Manager recommends approval of Temp. Reso. No. 8499 for the renewal of DocuSign Digital software licenses and maintenance services with Carahsoft Technology Corp. in the amount of \$185,537 for the fiscal year 2026.

**ISSUE:** City Commission approval is required for expenditures exceeding \$75,000 in accordance with City Code Section 2-412(a)(1).

**BACKGROUND:** The City implemented the DocuSign Digital Platform, an electronic signature and Contract Lifecycle Management (CLM) solution, to fulfill the need for electronic signatures and secure digital processes that automate these services, enhancing support for the City and its residents.

<u>DISCUSSION:</u> Renewing the DocuSign Digital software licenses and maintenance services for another year is crucial to maintaining the City's ongoing digitization efforts. This renewal ensures the continued use of electronic signatures and Contract Lifecycle Management (CLM) tools, which are vital for streamlining workflows, enhancing efficiency, and providing secure, automated services that support the City's operations and the needs of its residents.

Furthermore, pursuant to City Code Section 2-413(11)c, software license renewals and maintenance services are exempt from competitive bidding.
