RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No. 8327, approving the purchase of Law Enforcement Training and Professional Development Services from City of Miami Police College, in the amount of \$110,000 in FY25.

ISSUE: Pursuant to Section 2-412(a)(1) of the City's Procurement Code, approval of the City Commission is required for purchases or award of contract for goods or services in excess of \$75,000 by a single department from the same vendor in a single fiscal year.

BACKGROUND: The Police Department has encumbered \$60,200 in FY25 for Law Enforcement Training and Professional Development Services with City of Miami Police College via Purchase Order No. 250481. These services are exempt from competition under Section 2-413(11)(u) of the Procurement Code. It is expected that an additional \$49,800 will be spent with this vendor in FY25, bringing the total FY25 spend to \$110,000. The table below details the training expenditures approved and pending for FY2025.

<u>DISCUSSION:</u> The Police Department utilizes City of Miami Police College for training for non-certified police personnel. It is the goal of the Miramar Police Department to provide the community with the highest level of professional law enforcement services possible, and continued training and development of police personnel is critical to achieving this goal. The cost for each attendee is \$6,100. The total of \$110,000 will cover costs for 18 attendees.

ANALYSIS: Once approved, funds in the amount of \$49,800 will be transferred from GL account No. 001-20-201-521-000-604985 entitled "Grant Match" to GL account number 001-20-201-521-000-605500- entitled "Training General" and will be expended from this account.


