WHEREAS, Alexandra P. Davis ("Alexandra") was first elected to the Miramar City Commission in 2010 and after a four-year hiatus, Alexandra was re-elected in 2019. Alexandra and was sworn in as Commissioner for Broward County, District 7, on November 17, 204; and

WHEREAS, prior to Alexandra's election to the Miramar Commission, she brought her wealth of leadership experience and strong commitment to public service and served on various Miramar boards, including the Planning and Zoning Board, the Community Services Board, and the Education Board and in 2010 and;

WHEREAS, Alexandra was born in England and raised in Jamaica, where she attended Mico Practicing All Age School, Wolmer's Girls' High School, and the University of the West Indies and obtained a BSc. Degree in Zoology and Chemistry at their Mona camp; and

WHEREAS, Alexandra has spent most of her life in public service, having worked for the Ministry of Agriculture in Kingston, Jamaica, The Capital Taxes office in London, England, and Miami-Dade County Government in Florida; and

WHEREAS, in 2003, Alexandra created a non-profit organization called

Caribefest, Inc., to foster diversity, tolerance, and unity in the Miramar community, and

led to the creation of the Caribbean cultural festival, Caribefest, where the various cultures

of the Caribbean converged with the sights, sounds, and tastes of the islands; and

WHEREAS, Alexandra served Miramar's residents with integrity and distinction.

Alexandra was selected as Vice Mayor for 2019-2020 and again selected as Vice Mayor

in 2023; and

WHEREAS, since her election, Alexandra has proposed and successfully

implemented a body-worn camera program for the Miramar Police Department, among

other initiatives to Miramar, such as a tree trimming program and an art in public places

fund; and

WHEREAS, Alexandra proposed and secured Federal funding to add a Police

Social Worker, making Miramar the *first* Police Department in the state of Florida to do so

and to provide an additional tool for Community Policing; and

WHEREAS, Alexandra's vision led to the of the Afro Caribbean Festival that

highlights the African and Caribbean Diaspora during Black History Month and become

becoming the premier South Florida event; and

WHEREAS, Alexandra who is a certified teacher also formed a non-profit 501(c)(3)

in 2015 called the Caribbean American Teachers Association of Florida ("CATAF"),

whose motto is "Inspiring Students and Empowering Teachers;"

ICABA, one of the 50 Most Powerful and Influential Business Leaders in South Florida by

Legacy Magazine, the Jamaica Consul General's Jamaica 50 Luminous Award, one of

South Florida's Top Educators by Legacy Magazine, the Pinnacle Coceano Community

Leadership Award by the Miramar/Pembroke Pines Chamber of Commerce, and the

Africa Diaspora Women of Distinction Award; and

WHEREAS, Section 2-1 (b) of the City Code authorizes the City to name municipal

buildings, roads, bridges, parks, recreational complexes, or other similar facilities for

people who have made significant contributions to the City; and

WHEREAS, a nomination was made by Vice Mayor Yvette Colbourne to honor

and recognize Alexandra P. Davis for her lengthy and continued service to Miramar and

its residents and name the Miramar Multi-Service Complex to the "Alexandra P. Davis

Multi-Service Complex;" and

WHEREAS, to that end, the Miramar Multi-Service Complex will, upon ratification

of this resolution, be called the Alexandra P. Davis Multi-Service Complex; and
