RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No. 8416, approving the purchase of creative consultancy services for painting and application of a mural to the City's water tower from Evoca1 Art, LLC. in the amount of \$107,350.

ISSUE: Pursuant to Section 2-412(a)(1) of the Code, City Commission approval is necessary for a purchase or combined purchases by a single City department for commodities or services exceeding \$75,000 from the same person or entity in a fiscal year. This purchase is exempt from the competitive bidding process under Section 2-413(11) (p), Works of art for museum and public display of the City's Procurement Code.

BACKGROUND: The City of Miramar is celebrating its 70th anniversary this year. As part of the activities to commemorate this momentous milestone, the City is seeking to paint a mural on the water tower located at 6900 Miramar Parkway, which is one of the City's historic sites. After the completion of the mural, an unveiling event will be scheduled.

DISCUSSION: The proposal from Evoca1 Art, LLC. is for the painting of a mural on the water tower. The scope of work includes surface preparation, priming, mural application and anti-graffiti protective topcoat. The estimated timeframe for completion is 3 - 4 weeks.





PROGESS.



MIRAMAR WATER TANK - MIRAMAR, FL

BELOW IS A SUMMARY OF THE PROPOSED STEPS AND TREATMENT FOR PAINTING A MURAL ON THE MIRAMAR WATER TANK:

SURFACE PREPARATION

Existing coatings will be evaluated. Any rusted areas will be power-tool cleaned, spot-primed, and the surface cleaned in accordance with SSPC-SP1 (solvent cleaning standards).

PRIMING

We will apply Tnemec Series 135 Chembuild, a high-build epoxy primer designed for optimal adhesion over existing coatings and marginally prepared steel.

MURAL APPLICATION

The mural will be painted using professional-grade acrylic mural paints (such as Behr ultra, Golden Mural Paints or Nova Color), selected for their weather resistance, UV stability, and color retention.

ANTI- GRAFFITI Protective Topcoat

Once complete, the mural will be sealed with Tnemec Series 700 HydroFlon, a fluoropolymer polyurethane finish that offers long-term gloss and color retention and exceptional protection against UV and environmental exposure. We will also a layer of Sherwin William 2k Anti-Graffiti coating along walk way.

EQUIPMENT.

MIRAMAR WATER TANK - MIRAMAR, FL

FOR THE SUCCESSFUL EXECUTION OF THE MURAL ON THE MIRAMAR WATER TANK, THE FOLLOWING EQUIPMENT WILL BE REQUIRED:

BOOM LIFT (ARTICULATING OR TELESCOPIC)

To safely access all areas of the tank, including the curved and elevated surfaces. Lift height should accommodate work up to approximately 150 feet.

FALL PROTECTION GEAR

Safety harnesses and rigging systems compliant with OSHA standards for all personnel operating at heights.

AIRLESS SPRAY EQUIPMENT / PAINT SPRAYERS

For applying primer and topcoat efficiently on large surface areas. Mural details may be applied by brush or smaller sprayers.

GENERATOR (IF ON-SITE POWER IS UNAVAILABLE)

To power sprayers, lifts, and lighting, especially if work extends into low-light hours.

All equipment will be operated by trained professionals, with proper safety protocols in place.

INSTALLATION & RESPONSIBILITY

INSTALLATION & MATERIALS

Provide all labor, materials, and equipment necessary for the production and installation of the artwork mural.

Ensure installation does not alter, damage, or compromise the water tower's structural integrity or functionality.

Adhere to all applicable safety standards, building codes, and regulatory requirements during installation.

ARTIST RESPONSIBILITY

Maintain all required insurance coverage to perform work on the water tower, including liability and worker's compensation, as applicable.

Complete the installation within the timeframe specified by the City. The artist must promptly notify the City of any anticipated delays or issues that may impact the agreed-upon schedule.

Participate in up to two (2) design review meetings (in person or virtual) to discuss installation logistics and receive feedback.

Provide a comprehensive written maintenance and care plan for the mural/ wrap, covering a minimum period of five (5) years. ESTIMATED COST FOR PRODUCTION.
