RE: Temp. Reso. No. 8449 ArcGIS Enterprise Upgrade and ArcGIS Managed Services with NV5 Geospatial, Inc.

RECOMMENDATION: The City Manager recommends approval of Temporary Resolution No. 8449, authorizing the City to enter into an agreement with NV5 Geospatial Inc. ("NV5") for the provision of ArcGIS Enterprise Upgrade and ArcGIS Managed Services, in an amount not to exceed \$120,517.50. The agreement includes a waiver of competitive bidding requirements pursuant to City Code Section 2-413(4) and 11c, which pertains to sole source procurement and the renewal of software licenses and maintenance services, respectively.

ISSUE: City Commission approval is required for the approval of purchases exceeding the \$75,000 limit and waiving the competitive bidding requirements in accordance with City Code Section 2-413 (4 and 11c).

BACKGROUND: On July 8, 2020, the City Commission adopted Resolution No. 7209, approving a three-year Enterprise Agreement with Environmental Systems Research Institute, Inc. (ESRI). Subsequently, on June 12, 2023, the Commission approved Resolution No. 7900, renewing the ESRI Enterprise Agreement for another three-year term, ending July 2026.

The City's enterprise GIS server, implemented in 2020, currently operates on version 10.8.1, which now requires an upgrade to the latest version to provide enhanced capabilities and functionality. NV5 Geospatial Inc., an Esri Platinum Partner, holds specialized certifications in cloud-based ArcGIS implementations and utility network deployments, positioning them as the most qualified vendor to perform this work.

DISCUSSION: For over five years, the ESRI ArcGIS Enterprise Server has served as the City's geospatial platform, enabling staff to efficiently capture, manage, analyze, and share location-based data. The software supports GIS-centric workflows and enhances the City's capacity to pursue broader Smart City initiatives, such as:

- Open data and public information accessibility
- Location-based analytics
- Data-driven decision-making
- Seamless system integrations
- Real-time reporting and visualization
- Smart metering and infrastructure optimization

As a result of its investment in such technologies, the City of Miramar was recognized with a 2021 Smart 50 Award for its Advanced Metering Infrastructure (AMI) Project.

ANALYSIS: NV5 Geospatial Inc. possesses in-depth familiarity with the City's ESRI environment, having provided technical support and managed services since 2020. Their institutional knowledge and subject-matter expertise are crucial to ensuring the successful execution of the ArcGIS upgrade, as well as the continued reliability of the City's GIS-managed services, emergency fixes, and other mission-critical operations.

WHEREAS, on July 8, 2020, the City Commission adopted Resolution No. 20-151, approving a three-year Enterprise Agreement with Environmental Systems Research Institute, Inc. ("ESRI"), for the implementation of enterprise-level Geographic Information System ("GIS") services; and

WHEREAS, in June 12, 2023, the City Commission approved Resolution No. 23-

121, renewing the City's ESRI Enterprise Agreement for an additional three-year term,

ending July 2026; and

WHEREAS, the City's enterprise GIS server, implemented in 2020, currently operates on version 10.8.1 and requires an upgrade to the most recent version to enhance functionality and better alignment with the City's technological and operational goals; and

WHEREAS, NV5 Geospatial, Inc. ("NV5") is an ESRI Platinum Partner with specialized certifications in cloud-based ArcGIS implementations and utility network deployments, and has supported the City's ESRI environment since 2020; and

WHEREAS, NV5's institutional knowledge of the City's ESRI system is critical to the successful execution of the ArcGIS Enterprise upgrade and the continued provision of Managed Services, including emergency technical support and urgent fixes; and

WHEREAS, Section 2-413(4) of the City Code of Ordinances permits the waiver of competitive bidding when services are available only from a sole source vendor; and

WHEREAS, Section 2-413(11c) of the City Code authorizes the procurement of software licenses, maintenance, and licensing agreements supporting the continued use of proprietary software applications without competitive bidding; and

WHEREAS, the City Manager recommends approval of the proposed agreement; and

WHEREAS, the City Commission finds it in the best interest of the citizens and residents of the City of Miramar to enter into agreements for the ArcGIS Enterprise Upgrade and ArcGIS Managed Services, as set forth in Exhibits "A" and "B," respectively in an amount not to exceed \$120,517.50;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA AS FOLLOWS:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are made a specific part of this Resolution.

Section 2: The City Commission hereby approves the ArcGIS Enterprise Upgrade and ArcGIS Managed Services Contracts with NV5 Geospatial, Inc., in the forms attached hereto as Exhibits "A" and "B," respectively in an amount not to exceed \$120,517.50.

Section 3: The City Commission authorizes the City Manager to execute the ArcGIS Enterprise Upgrade and ArcGIS Managed Services Contracts with NV5, in the form attached hereto as Exhibits "A" and "B," respectively subject to approval as to form and legal sufficiency by the City Attorney.

Section 4: The appropriate City officials are authorized to do all things necessary and expedient to carry out the aims of this Resolution.

Section 5: That this Resolution shall take effect immediately upon adoption.

ArcGIS Enterprise is a full-featured mapping and analytics platform. It includes a powerful GIS web services server plus dedicated Web GIS infrastructure for organizing and sharing your work in order to make maps, geographic information, and analyses available on any device, anywhere, at any time.
