The City must commit to provide local funding for the construction cost of extension of the eastbound turn lane along Miramar Parkway from Dykes Road for the I-75 on-ramp. The estimated cost for the construction of this improvement is \$280,000. FDOT anticipates the construction of this project to begin in FY 22; therefore, the City will need to adopt a new CIP project in the FY 20-24 five-year plan with funding identified in the FY 21 CIP budget.

No. R6947, endorsing the Florida Department of Transportation Pembroke Pines/Miramar Mobility Improvements Project No. 431770-4 within the City of Miramar's right-of-way along Dykes road and requesting FDOT to incorporate the extension of the eastbound turn lane along Miramar Parkway from Dykes Road

RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No. R6947, endorsing the Florida Department of Transportation ("FDOT") Pembroke Pines/Miramar Mobility Improvements Project No. 431770-4 (the "Project") within the City of Miramar's right-of-way along Dykes Road.

ISSUE: City's support and endorsement is required for FDOT's Project within the City of Miramar's right-of-way along Dykes Road.

BACKGROUND: On October 7, 2015, the City of Miramar Commission adopted Resolution No. 16-01, expressing support to the Broward Metropolitan Planning Organization ("MPO") for construction of bicycle lanes along Dykes Road. The MPO obtained federal funding to be appropriated towards mobility enhancement projects, including Project. A portion of the Project falls within the City's jurisdictional right-of-way along Dykes Road between Pembroke Road and Bass Creek Road. The scope of the project within the City's right-of-way includes the design and construction of buffered bike lanes (4' wide bicycle lane with 2' buffer) on both sides of Dykes Road.

The City is requesting FDOT to incorporate the extension of the eastbound turn lane along Miramar Parkway from Dykes Road for the I-75 on-ramp into this Project. The extension of this turn lane will help alleviate the traffic congestion at the intersection of Dykes Road and Miramar Parkway in the morning peak time. This improvement will also complement the northbound right turn lane along Dykes Road that is to be constructed by Lennar Homes in the near future. FDOT will be responsible for the Project, which includes the necessary design, construction, and project management services. The City must endorse FDOT's Project for the portion that lies within the City's jurisdictional right-of-way. In addition, the City must commit to provide local funding for the construction cost of the extension of the eastbound turn lane along Miramar Parkway for the I-75 on-ramp. In the future, the City will be required to enter into a Locally Funded Agreement with FDOT, defining the scope and establishing the funding responsibilities for this additional improvement. The estimated cost for the construction of this improvement is \$280,000. FDOT anticipates the construction of this project to begin in FY 22; therefore, the City need to include funding for this project in FY 21 CIP budget.

WHEREAS, the City of Miramar supports the completion of sidewalk and bicycle

lane networks along the City's right-of-way to provide safe pedestrian and bicycle pathways; and

WHEREAS, the Broward Metropolitan Planning Organization ("MPO") obtained

federal funding to be appropriated towards mobility enhancement projects; and

WHEREAS, the MPO designated federal funding towards the Pembroke

Pines/Miramar Mobility Improvements Project No. 431770-4 (the "Project"); and

WHEREAS, a portion of the Project falls within the City of Miramar's jurisdictional

right-of-way along Dykes Road between Pembroke Road and Bass Creek Road; and

WHEREAS, the scope of the Project within the City's right-of-way includes the construction of buffered bicycle lanes (4' wide lanes with 2' wide buffer) on both sides of Dykes Road; and

WHEREAS, the City is requesting FDOT to incorporate the extension of the eastbound turn lane along Miramar Parkway from Dykes Road for the I-75 on-ramp; and

WHEREAS, the City, MPO, and FDOT have agreed that FDOT will be responsible for the necessary design, construction, and project management services for the Project; and

WHEREAS, the City must endorse FDOT's Project, which falls within the City's jurisdictional right-of-way; and

WHEREAS, the City must commit to provide local funding for the construction cost of the extension of the eastbound right turn lane along Miramar Parkway from Dykes Road to the I-75 on-ramp; and

WHEREAS, the City will be required to enter into a Locally Funded Agreement with FDOT for the construction cost of the extension of the eastbound right turn lane along Miramar Parkway from Dykes Road to the I-75 on-ramp in the near future; and

WHEREAS, the City Manager recommends that the City Commission approve the City's endorsement of FDOT's Project and request the extension of the eastbound right turn lane along Miramar Parkway from Dykes Road to the I-75 on-ramp; and

WHEREAS, the City Commission deems it to be in the best interest of the citizens and residents of the City of Miramar to endorse FDOT's Project and request the extension of the eastbound right turn lane along Miramar Parkway from Dykes Road to the I-75 onramp.
