**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF
MIRAMAR, FLORIDA, AMENDING THE CITY CODE AT
CHAPTER 2 "ADMINISTRATION," ARTICLE III "BOARDS,
COMMITTEES AND COMMISSIONS," DIVISION 6 "TEEN
COUNCIL ADVISORY BOARD," SECTION 2-105.5 TO PROVIDE
FOR ADDITIONAL MEMBERS; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the City Code presently provides for 10 members for the Teen Council
Advisory Board ("Board"); and

WHEREAS, the City Commission wishes to add 2 more members to the Board
and provide for their appointment and removal; and

WHEREAS, the City Commission deems it to be in the best interest of the residents
and citizens of the City to amend the City Code to add 2 members to the Board
membership and provide for their appointment and removal.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF
MIRAMAR, FLORIDA AS FOLLOWS:**

Section 1: That the foregoing "**WHEREAS**" clauses are ratified and confirmed
as being true and correct and are made a specific part of this Ordinance.

Section 2: That Section 2-105.5 of the City Code is hereby amended to read as
follows:

ARTICLE III. – BOARDS, COMMITTEES AND COMMISSIONS

DIVISION 6. – TEEN COUNCIL ADVISORY BOARD

Sec. 2-105.5 Membership; application; term of office

The board shall consist of ~~ten~~twelve (12) members as follows:

- (1) There shall be ten (10) members, two (2) members appointed by each member of the city commission.
- (2) There shall be two (2) members appointed by a majority vote of the city commission as a whole ("At Large Members").

~~and each member of the city commission shall be responsible for appointing two (2) members.~~ Any member of the city commission may nominate an At Large Member. Whenever possible, the city commission shall appoint equal members of middle school and high school age students, who shall be representative of the youth of Miramar with respect to age, gender, ethnicity and residency.

Any middle school to high school aged student living in the City of Miramar will be eligible to serve on the board.

Applicants for appointment to the board shall submit an application form as provided by the director of parks and recreation ~~community services~~, accompanied by written permission from a parent or legal guardian authorizing the applicant to attend the prescribed meetings and participate in the activities of the board.

The term of office for each member shall be through high school graduation or removal from the board by the city commission, as provided in Section 2-51. ~~one (1) year.~~ Reappointments, if necessary, shall be made in ~~September~~ June of each year, ~~and shall remain effective until the end of May of each year.~~ Once a member graduates from school, he or she will no longer be eligible for a seat on the Board and will be automatically removed from that position. Any vacancy arising prior to completion of a term shall be filled by appointment made by the mayor or city commissioner responsible for the appointment of the vacant member for the remainder of the term.

Section 3: That all sections or parts of sections of the City Code, all ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

Section 4: That should any section or provision of this ordinance, or any paragraph, section or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof, as a whole or part hereof, other than the part declared to be invalid.

Section 5: That it is the intention of the City Commission that the provisions of this ordinance shall become and be made part of the Code of the City of Miramar, and that the sections of this ordinance may be re-numbered or re-lettered and the word "Ordinance" may be changed to "Chapter", "Section", "Article" or such other appropriate word or phrase, the use of which shall accomplish the intentions herein expressed.
