RE: Temp. Reso. No. 7222 Confirming the City of Miramar's support of Broward

County in its efforts to provide adequate hurricane shelter staffing

RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No. 7222, confirming the City of Miramar's support of Broward County in its efforts to provide adequate staff to ensure for the safe and efficient operation of shelters required to protect Broward County residents in the event of a hurricane.

ISSUE: Emergency shelter staffing was previously provided to Broward County through an arrangement with the American Red Cross ("ARC"). The ARC is no longer providing this function and a comprehensive emergency shelter staffing program does not currently exist in Broward County. Broward County has requested the support of municipalities in developing and supporting a new shelter staffing program.

BACKGROUND: Over the past year, Broward County, the School Board, and Broward municipalities have discussed options to provide shelter staffing solutions subsequent to the discontinuation of the services by the ARC. All parties understand that in the event of a hurricane or other emergency, cities are primarily focused on assembling essential personnel to prepare for and respond to the emergency; however, other general employees, not engaged in emergency operations, may be available to help bridge the gap for shelter staffing. The County is asking that these employees be identified, trained and ready to respond to shelters if they are needed.

<u>DISCUSSION</u>: The need for adequate staffing of emergency shelters in Broward County is a critical component of protecting our communities during a disaster. The National Oceanic and Atmospheric Administration (NOAA)'s Climate Prediction Center, a division of the National Weather Service, has advised that the 2020 Atlantic Hurricane Season

will be "above-normal". The State of Florida and Broward County are in the typical pathway of Atlantic hurricanes and should prepare for a worse-case scenario incident.

Broward County Public Schools have systematically been used for shelters, including schools within the City of Miramar. It is imperative that the City of Miramar and surrounding areas are prepared to accept residents in the event shelters are needed due to an impending hurricane or other emergency.

ANALYSIS: Broward County assumed the responsibility of providing shelters to its residents during emergencies after ARC and FEMA decided to no longer provide support shelters operations. Consequently, Broward County Administrator issued a request to all County municipalities for assistance with staffing its shelters. Administration recommends offering 18.5 non-essential employees to support the shelters in 2020. The 18.5 employees are in addition to public safety personnel already assigned to support Miramar shelters.

The City will assume no fiscal responsibilities as the County will provide funds for the 12.5% match required by FEMA, in addition to paying for all associated training costs involved with preparing employees for shelter operations.

The City of Miramar is prepared to accommodate the County Administrator's request as there will be no fiscal impact and the City will be able to provide the non-essential workforce required to operate the shelters effectively and safely.

WHEREAS, the City Commission approves and authorizes the City Manager to enter into an Interlocal Agreement ("ILA") with Broward County in support of Hurricane Shelter staffing; and
