RECOMMENDATION: The City Manager recommends approval of Temp. Reso. No. 7516, recognizing and approving Florida State Lodge, Fraternal Order of Police ("FOP") as the new Union representing all City of Miramar sworn Police Officers and Sergeants, effective October 5, 2021. Approval of FOP is required to adopt the Police Benevolent Association, Inc. (PBA)'s current contract.

ISSUE: The previous collective bargaining agreement between the City and PBA expired on September 30, 2021. The City and PBA negotiated, in good faith, to create a successor agreement for the period of October 1, 2021 through September 30, 2024. City Commission approved the agreement on August 18, 2021.

Members of the bargaining unit sought to decertify the PBA. An election was held amongst the membership and FOP was elected to replace PBA. FOP has agreed to adopt the PBA contract. City Commission approval is necessary to authorize the adoption.

BACKGROUND: The PBA represents the police officers and sergeants employed by the City. The City and PBA negotiated a new collective bargaining agreement for the period of October 1, 2021 through September 30, 2024. The agreement was approved by the City Commission at the August 18th Commission meeting.

While the negotiations process was ongoing, employees in the bargaining unit began the decertification process of the PBA. On June 3, 2021, FOP filed a petition with Public Employees Relations Commission (PERC) seeking to represent a rank-and-file bargaining unit of sworn law enforcement personnel employed by the City of Miramar,

currently represented by PBA. On August 23, 2021, the City was advised that PERC will be holding an election on September 16 and 17, 2021 between PBA and FOP. On September 17, 2021, FOP prevailed with fifty-five votes and PBA lost with fifty-one votes.

<u>ANALYSIS:</u> The FOP adoption of the PBA agreement does not result in any changes of the cost of the agreement.

WHEREAS, the previous collective bargaining agreement between the City and the Broward County Police Benevolent Association, Ince (PBA) expired on September 30, 2021; and

WHEREAS, the City and the PBA have negotiated in good faith to create a successor agreement; and the City Commission approved the agreement on September 28, 2021; and

WHEREAS, the PBA is no longer representing City of Miramar police officer and sergeants.; and

WHEREAS, on June 3, 2021, FOP filed a petition with Public Employees Relations Commission ("PERC") seeking to represent a rank-and-file barging unit of sworn law enforcement personnel employed by the City of Miramar currently represented by PBA.; and

WHEREAS, on August 23, 2021, the City was advised PERC will be having an election on September 16 and 17, 2021 between PBA and FOP; and

WHEREAS, on September 17, 2021, FOP prevailed with fifty-five votes and PBA lost with fifty-one votes; and

WHEREAS, on September 24, 2021, FOP advised the City they desire to adopt the existing collective bargaining agreement and will maintain and service it until a successor agreement is negotiated upon the expiration of the agreement; and

WHEREAS, the City Commission deems it to be in the best interest of the citizens and residents of the City of Miramar to approve the adoption of the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA AS FOLLOWS:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission approves and recognizes FOP as the new union representing all sworn police officers and sergeants. The City Commission approves FOP adopting the current CBA.
